Thank you for your business. This Schedule of Miscellaneous Account and Service Fees provides details on transaction fees that may affect your account(s) with Voya Financial Advisors, Inc. (VFA). Please note that these fees may not be itemized on your confirmations or statements. Certain fees are a combination of a fee charged by VFA's clearing firm and your account custodian, Pershing, LLC (Pershing) and an associated fee by VFA. Please note that these fees are effective as of the date of this Schedule. The specifics for each fee can be found in the table below. Some of these fees may not apply to all account types. The fees reflected are the highest fee rate for the particular account or service and some account types may charge a fee lower than the fee disclosed herein. Fees may be waived at the sole discretion of VFA.

These fees are in addition to any commission(s), mark-ups, commission equivalents or advisory fees that your registered representative or investment adviser representative charges to effect securities transactions within your account. Brokerage commissions and commission equivalents for equity and debt transactions are assessed by your registered representative at his or her sole discretion, subject to certain limits imposed by VFA. Investment Company security commissions are paid in accordance with such security's prospectus. Investment advisory fees are disclosed in your investment advisory contract with VFA. Please contact your registered representative or investment adviser representative for more information regarding any commissions, mark-ups, commission equivalents or advisory fees charged within your account.

<sup>2</sup> Inactive accounts are defined as accounts with no trading activity (dividends and interest are not included as activity) during the "inactive period". The "inactive period" runs from January 1 to December 31. An account is not considered inactive if it is a Pershing custodial account such as an IRA, SEP or qualified Retirement plan, or Corestone account.

<sup>3</sup> Legal Transfers – Transfer of securities where proof of signature is attached, such as corporate resolutions, power of attorney, death, etc.

<sup>4</sup> The fee amount charged for execution of securities transfers to or from a transfer agent, whether for physical certificates or book entry, is dictated by the transfer agent used to fulfill the transfer. The amount varies depending on the transaction type and transfer agent used. Information regarding the transfer agent(s) utilized by a particular securities offeror may be found on the offeror's investor relations website.

<sup>5</sup> Paper Statement charge applies to statements and confirmations for accounts up to \$250,000 in assets unless registered for electronic delivery. The paper surcharge is waived on retail brokerage accounts with \$250,000 or more in assets.

<sup>7</sup> Foreign Security receive and deliver – Charged for any transfer in or out of foreign securities held within a brokerage account. Non-USD settlement fee if processed in local currency.

<sup>8</sup> Foreign Security holding fee – Charged per foreign security position held within a brokerage account.

<sup>9</sup> For additional information on any fund available through the FundVest programs, including charges and expenses, please consult the respective fund's prospectus. Positions acquired without a transaction fee must be held for a 30-day period to be eligible for a no-fee redemption. Any redemption made prior to the position's 30-day anniversary, in any program, will incur a short-term redemption fee.
